# Presidential Column

**2015** was a busy and very controversial year at APA. In the summer, the Hoffman report was released. It concluded that APA had implicitly condoned our national security agencies' use of extreme measures in their interrogation techniques. Lead by our 2 council reps, Kang Lee and Suniya Luthar, our Executive Committee had lengthy and highly productive discussions about the many possible responses we should make as a division to this information, ranging from all of us resigning, to boycotting the 2015 convention, to hoping APA Council would take care of the situation in an appropriate manner. Suniya, in particular, played a major role in getting the APA leadership to hold a town hall meeting at the convention and creating more transparent processes for replacing the several APA officials, including its CEO, who either retired or resigned as a consequence of the report. Suniya says more about this whole affair in her column in this newsletter. Let me say, all of us were embarrassed to be part of an organization that had not strongly protested against the use of torture. In the end, we decided it was better to remain members and to fight for change in APA from within. Our division played a very active role in the discussions that grew out of this report and our council reps are continuing to play a major role in its aftermath. Hopefully, APA will emerge a more transparent organization that better represents the ethics of its membership.

Over the years, APA has tried to reform the convention so that it

better meets the needs of its membership and the more general community. It has tried several different formats. In 2015, it introduced much greater emphasis on interdisciplinary and cross-division collaborative sessions. Under the leadership of Sandra Simpkins and Jennifer Fredricks, we participated in very first APA divisions. Over the years, through its Executive Committee, other committees and its APA Council Reps, we have played a very active role in APA, making sure that children's interests and developmental scholarship were supported. We remain one of the strongest scientific-research-



several collaborative sessions in Toronto, most of which were very well attended. Jenny Fredricks has carried on this tradition for our 2016 convention program. Again, she was able to create several collaborative sessions, all of which look very interesting. She says more about this in her column in this newsletter. I encourage you to attend. Colorado is spectacular at that time of year and the convention program looks great.

One of the issues we discussed a great deal this past year is exactly what should be the role of Division 7 for its members as well as for the APA and our profession more generally. Division 7 was one of the

very first APA divisions. Over the years, through its Executive Com-APA Council Reps, we have played a very active role in APA, making sure that children's interests and developmental scholarship were supported. We remain one of the strongest scientific-researchfocused divisions in APA and have done our best to keep the interests of our research communities salient in APA. But over the years, many research psychologists have shifted their professional focus to APS and various other more specialized, research-focused professional organizations. Several of the more research-focused divisions have broadened their membership beyond APA and started hosting their own journals and conferences in order to better meet the needs of the members.

Should Division 7 try similar strategies to better meet the needs of our membership? Our membership numbers continue to fall. How should we respond to this decline? Beyond the conference, our newsletter, our awards, and the journal Developmental Psychology, what are we providing for our members? What should we be providing? Over the last year, we have had several discussions about these questions and failed to reach a consensus about exactly what our future mission should be. Developmental psychologists are fortunate to have several quite strong and active professional international and national organizations. These organizations already hold major international conferences and offer a variety of smaller, more focused conferences

and training retreats. Do we want or need more of these kinds of professional development opportunities?

There are also several APA divisions interested in developmental issues at various points across the life span. Should we try to integrate activities across these various divisions beyond the integration that is already occurring in collaborative sessions at the annual APA convention and the various collaborative task forces in which we participate? We would like more input on these issues from our membership as we develop our long-term plans. Please contact me at <a href="mailto:iseccles@uci.edu">iseccles@uci.edu</a> with your suggestions.

Each year we elect members to several different positions, including president elect, secretary, treasurer, members at large on the EC, members of the fellow selection committee, student representatives and early career representatives. We also appoint people to our various committees. We would like to include more of our members in these activities. To do so, we need volunteers and nominations for the elected offices. # The Hoffman Report and Division 7

### Report from representative to APA Council (2013-2016), Suniya S. Luthar

In November 2014, the APA Board of Directors engaged David Hoffman of the law firm Sidley Austin to conduct an independent review to establish if APA had, in any way, facilitated the use of torture in security settings. Specifically, they sought to ascertain if any actions by APA could have constituted collusion with the Bush administration toward supporting the use of "enhanced" interrogation techniques in the "war on terror". Here are direct links to the complete independent review and supplemental materials.

After the report was released, APA issued a <u>Press Release</u> with a public apology and reports of the impending departures of several senior officials. The glowing praise for each of these senior officials <u>were at odds</u> with what was reported in other major <u>news</u> outlets based on data in the Hoffman report.

At the time, Division 7 representatives asked who, specifically, crafted and authorized the Press Release but never received a clear answer. After several efforts to determine this, the closest we got was that this it was "the Board" that authorized the Release. At the time, the Board included the following individuals; subsequent emails to Division 7 Reps indicated that individuals with asterisks, specifically, did not author the Press Release (including recusals): Susan McDaniel, Nadine Kaslow, Jennifer F. Kelly, Emily A. Voelkel, Louise A. Douce, Richard M. McGraw, Norman B. Anderson\*, Barry S. Anton\*, Bonnie Markham\*, Linda F. Campbell\*, Diana Lee Prescott\*, Sandra L. Shullman\*, William J. (Bill) Strickland\*.

In August 2015 at the meeting in Toronto, APA Council of Representatives unanimously voted to support a



resolution to prohibit psychologists from Participating in National Security Interrogations. In recent months, however, it has become clear that some are moving to reverse this unanimous decision; the response from the Coalition for an Ethical Psychology is here.

Given the ongoing contentiousness and serious ramifications of the issues at hand, the stand that Division 7 has consistently taken is to convey, to APA leadership and Council, support for APA while underscoring the urgent need for transparency in major decisions. This is exemplified in an October 5, 2015 letter sent by President Jacque Eccles to the Board of Directors.

"We, as the presidents of Division 7, write to offer our personal support through this trying period for APA, and also, on behalf of Division 7 members, to ask a couple of questions. Following up on proceedings at the August meetings, there are two specific questions that have recurrently come to us. We hope to share your answers directly with our members toward establishing / reassuring all that that APA leaders are indeed resolutely standing by assurances made in Toronto.

- In your remarks at the Town Hall meeting, Dr. McDaniel, you declared that in the search for the new CEO, "a diverse and representative search committee is really important' and this would include some of the "dissidents". Could you please let us know the names of these dissidents who are included in the committee searching for the interim CEO, and eventually, for the appointed CEO?
- Three senior APA officials are resigning or retiring; could you please outline the conditions associated with their departures? Specifically, our members would like to know details of the severance packages for all three, and any contractual agreements regarding further disclosure about matters related to Hoffman.

We believe that your answers just to these two questions

could help greatly in stanching increasing member resignations from our Division and from APA, serving as a concrete demonstration of "good faith" on behalf of your leadership. We look forward to your answers to these questions.

Most recently, this was followed up by this letter that I sent to Council, copied to APA Board, on behalf of our Division:

### "Dear COR colleagues,

I write with increasing concerns about membership / resources / tasks in our organization, on these topics (among potential others):

Accreditation programs. I recently wrote to you all regarding Bob Levenson's APS column. There are real concerns that more APA programs will move to APS for accreditation because of fears that no substantive changes have been made by APA since the Hoffman report. Colleagues are looking for changes that will ensure that such egregious events never occur again at APA, with particulars of checks and balances that are to be instituted — including those applying to decision-makers at the highest levels.

**Journals.** In addition to the potential loss of APA's accreditation prerogatives, suggestions are being floated that entire journals —editors, editorial boards, and staff — move to non-APA publishers. Whether or not

this will happen, just the conversations are worrisome. Journal publications are critical to the scientific mission of our organization, its reputation, its community, and its financial solvency.

I do hope, therefore, that in our forthcoming Council meeting we are able to resolve at least two critical issues, each raised by Division 7 Presidents and EC members in the last few months:

A balanced CEO search committee. Particularly helpful toward restoring faith in APA will be a CEO search committee that includes those vetted by the "dissidents," as Dr. McDaniels promised at Toronto Town Hall.

Transparency. Also necessary for restoring faith would be straightforward disclosure of the names of the specific authorities whose decisions have a major bearing on our organization and its reputation. It is not enough to be told that, "The Board decided." We should be told which individuals supported and opposed major decisions.

Thank you for considering these concerns of grave importance to the future of APA.

We have had no response to this request. Thus, we will formally request discussion of the two issues noted above (i.e., constitution of the search committee and transparency). We are hoping that this will be discussed in the near future, and will report back after Council meeting is done.





# AWARDS FOR STUDENTS AND EARLY CAREER SCHOLARS

### Dissertation Award in Developmental Psychology

Description: This award is given to an individual whose dissertation is judged to be an outstanding contribution to developmental psychology. Award winning dissertations demonstrate strong contribution to developmental science and theory through asking important questions and displaying theoretical rationale and systematic methods. A distinguished dissertation includes a well written summary and is publishable in a top journal. Winners are presented at the APA Annual Convention.

### **Eligibility:**

- The nominee must have completed his/her dissertation as part of a developmental graduate program.
- The nominee must have participated in his/her dissertation defense during the current or prior calendar year of the award.

**Deadline**: March 15, 2016 **How to Apply:** 

Nominations should include:

- An electronic summary of the research (maximum of 2,000 words, excluding references).
- Electronic letter form the chair of the student's dissertation committee attesting to the student's primary and major contributions to the research and explaining why the dissertation is worthy of the award.

### **Boyd McCandless Award**

**Description**: The Boyd McCandless Award recognizes a young scientist who has made a distinguished theoretical contribution to developmental psychology, has conducted programmatic research of distinction, or has made a distinguished contribution to the dissemination of developmental science. The award is for continued efforts rather than a single outstanding work. The award is presented by the membership of Div. 7 of the APA, and the award winner will be invited to address the following year's meeting of the APA.

### Early Career Outstanding Paper Award

**Description**: The paper must significantly advance content knowledge, methodology and/or theory in developmental psychology. Important criteria include the importance of the work, innovation and the likely impact on the field. The nominee must be the first author and must be a member of APA and Division 7.

# Division 7 Funding Opportunities

### **DISSERTATION RESEARCH GRANT IN DEVELOPMENTAL PSYCHOLOGY**

Between one and three \$500 grants are awarded each year. The in-progress research must significantly advance content knowledge, methodology and/or theory in developmental psychology. Criteria include the project's importance, innovation, feasibility, funding needs and likely contribution to the field, as well as the applicant's record.

**Eligibility**: Eligible doctoral students are within one year of successfully defending their dissertation proposal (or the program's equivalent requirement) at time of application for the dissertation grant. The dissertation proposal must have been approved by the dissertation/orals committee (or the equivalent, depending on the doctoral program requirements). Applicants must be nominated by their faculty supervisor. Awardees will submit a report at the end of their dissertation, describing the results and how the funds were used. Funds cannot be applied to conference travel.

Deadline: March 15, 2016

**How to Apply**: Applications will include a letter of recommendation from the faculty supervisor, the student's CV, a one-page budget with justification (e.g., why the funds are needed), and a one-page single-spaced research proposal outlining the research question, the rationale for the study, the methodology, the significance, and the expected contribution to knowledge.

### EARLY CAREER RESEARCH GRANT IN DEVELOPMENTAL PSYCHOLOGY

The Early Career Research Grant supports the research of outstanding early career members of Div. 7 who have not yet received any federal funding for research as a principal investigator or co-investigator (pre-PhD training funds or F<sub>31</sub> grants are not counted). One or two of these \$1,000 grants will be awarded each year, as possible.

Eligibility: Eligible assistant professors (pre-tenure as of Oct. 1, 2015) and postdoctoral scholars (within five years past receipt of the doctoral degree) may apply. The proposed or in-progress research must significantly advance content knowledge, methodology and/or theory in developmental psychology. Criteria include the project's importance, innovation, feasibility, funding needs, likely contribution to the field and the applicant's record. Awardees will submit a report at the end of their project and no later than two years after the award, describing the results and how the funds were used. The report should be in a form that facilitates Div. 7's posting it on the website and/or including it in the newsletter. Funds cannot be applied to conference travel.

Deadline: March 15, 2016

**How to Apply:** Applications will include the applicant's CV; a one-page budget with justification (e.g., why the funds are needed); a three-page single-spaced research proposal outlining the research question, the rationale for the study, the methodology, the significance and the expected contribution to knowledge. In the case of multi-investigator studies, the application should make clear the specific contribution of the applicant.


